2	<p>1. In the final: what exact we should present? The device for tracking and a software to process data OR only a software?</p> <p>2. Is the solution we will offer should work in the whole EU only - geographically? Or, maybe non-EU members should have a possibility of being tracked too?</p> <p>3. Should we as developers send you the right of managing the software/solution we'll offer? Or, we could commercialise our software to other markets?</p>	<p>Many thanks for your email and for your questions regarding the unique train prize.</p> <p>Please see our answers to your questions below:</p> <p>1. The objective of the prize is to develop a solution to track the commercial trains, It should be, ready to use, easily exportable to a data hub manager and scalable and usable by all actors of the logistic chain. The proposed innovative solution will be evaluated against the criteria described in section 5 of the Rules of Contest.</p> <p>2. As described in the Rules of Contest, the solution will allow the tracking of commercial freight trains, covering the whole European Network. The objective is to provide real time information about the train, including information on the location, departure, destination, composition and punctuality across Europe.</p> <p>3. As indicated in the rules of contest, the winner(s) must comply with the obligations set out in Title III of the Horizon 2020 Rules for Participation Regulation No 1290/2013 (<a href="https://ec.europa.eu/research/participants/data/ref/h2020/legal_basis/rules_participation/h2020-rules-participation_en.pdf">https://ec.europa.eu/research/participants/data/ref/h2020/legal_basis/rules_participation/h2020-rules-participation_en.pdf</a>). In particular, results shall be owned by the participant generating them, but there is an obligation to protect results, exploitation and dissemination obligations, as well as rules determining the transfer and licensing of results and access rights to background and results. For more information and best practice, see Articles 23a-31 of the H2020 AGA — Annotated grant agreement. Moreover, in line with the announced award criteria, solution should be, inter alia:</p> <p>-Interoperable with different existing systems and standards, i.e. systems in use by IMs and/or RUs, Hermes 30, EDIGES, port community systems, TIS.</p>

		- Not dependent on proprietary solutions, using open standards. Potentially exportable to a "data hub manager".

That is, to present a document including some tasks to be done with the money if being awarded with the prize.Thanks a lot for your support in advance and have a nice day!</p>	<p>Thank you for your interest in the S2R Joint Undertaking activities and the UTrain prize.</p> <p>To answer your question, I refer to point 1.2 of the Rules of Contest (RoC) for this prize: <i>"The solution should demonstrate its technical validity and universality while at the same time it should provide a viable path (of measures and advantages) to go beyond the current state of play and open to further developments of the single Train ID."</i></p> <p>So, the solution has to be developed and has to be ready to use (see section 5 of the RoC), easily exportable and scalable.</p> <p>Also please bear in mind that the proposed solutions that pass the thresholds set in Section 7 of the RoC will be invited to demonstrate their solution.</p> <p>I hope this answers your question.</p> <p>Best regards</p> <p>The S2R JU Team</p>

If no, could you explain us how show you our system work fine?</li> </ol>	<p>Thank you for your question and interest in the Unique Train Prize.</p> <ol style="list-style-type: none"> <li>1- With respect to the language of proposal, please be informed that the official EU languages are allowed. However, the summary of the proposal (part B) must always be in English even if the rest of your proposal is in another EU language. Please also be reminded that according to the Rules of Consent, the applications must be readable, accessible and printable. Incomplete applications may be considered inadmissible if essential elements are missing.</li> <li>2- In terms of the application process, it consists of two stages. First stage concerns the submission of a proposal.
